### **Location Information**

Just to give an overview of the proposed venues above;

#### **Goa- Hotel Grand Hyatt**

Goa is India's smallest state by area and the fourth smallest by population. Located in West India in the region known as the Konkan, it is bounded by the state of Maharashtra to the north, and by Karnataka to the east and south, while the Arabian Sea forms its western coast.

Goa is India's richest state with a GDP per capita two and a half times that of the country as a whole. It was ranked the best placed state by the Eleventh Finance Commission for its infrastructure and ranked on top for the best quality of life in India by the National Commission on Population based on the 12 Indicators.

Goa is very popular among tourist from India and Abroad and many conferences are held on regular basis

### **Hyderabad- Hyderabad International Convention Center (HICC)**

Hyderabad International Convention Center (HICC) is managed by ACCOR jointly owned by EMAAR properties PJSC Dubai and Andhra Pradesh Industrial Infrastructure Corporation Ltd. HICC is the first purpose – built and state of the art convention facility, the first of its kind in South-Asia.

Hyderabad is the capital and largest city of the southern Indian state of Andhra Pradesh. Hyderabad is the largest contributor to the gross domestic product (GDP), tax and other revenues, of Andhra Pradesh, and the sixth largest deposit centre and fourth largest credit centre nationwide, as ranked by the Reserve Bank of India (RBI) in June 2012.

The growth of the financial services sector has helped Hyderabad evolve from a traditional manufacturing city to a cosmopolitan industrial service centre. Since the 1990s, the growth of information technology (IT), IT-enabled services (ITES), insurance and financial institutions has expanded the service sector, and these primary economic activities have boosted the ancillary sectors of trade and commerce, transport, storage, communication, real estate and retail.

### **Bangalore – Vivanta by Taj**

**Bangalore** is the capital city of the Indian state of Karnataka. Located on the Deccan Plateau in the south-eastern part of Karnataka, Bangalore is India's third most populous city and fifth-most populous urban agglomeration. Bangalore is well known as the hub of India's information technology sector. The city is amongst the top 10 preferred entrepreneurial locations in the world. As a growing metropolitan city in a developing country, Bangalore confronts substantial pollution and other logistical and socio-economic problems

Bangalore is home to many well-recognized educational and research institutions in India. Numerous public sector heavy industries, technology companies, aerospace, telecommunications, and defense are located in the city. Bangalore is known as the *India because* of its position as the nation's leading IT exporter. A demographically diverse city, Bangalore is a major economic and cultural hub and the second-fastest growing major metropolis in India.

### **Cochin – Le Méridien Kochi**

**Kochi** formerly **Cochin**, is a major port city on the west coast of India by the Arabian Sea and is part of the district of Ernakulam in the state of Kerala. Kochi is often called by the name Ernakulam, which refers to the mainland part of the city.

Kochi ranks first in the total number of international and domestic tourist arrivals in Kerala. Kochi has been ranked the sixth best tourist destination in India according to a survey conducted by the Nielsen Company on behalf of the Outlook Traveller magazine Kochi was one of the 28 Indian cities found to be among the emerging 440 global cities that will contribute 50% of the world GDP by the year 2025, in a

study done by McKinsey Global Institute.

The IT and ITES related industries are growing up in Kochi.

Availability of heap bandwidth through undersea cables and lower operational costs compared to other major cities in India, has been to its advantage. Various technology and industrial campuses including the government promoted InfoPark, Cochin Special Economic Zone and KINFRA Export Promotion Industrial Park operate in the outskirts of the city. Several new industrial campuses are under construction in the suburbs of the city. SmartCity at Kakkanad is the prominent project under proposal. Cyber City at Kalamassery is another integrated IT township SEZ being planned in the private sector.

#### **Accessibility;**

India is well connected to all International and domestic destinations. There are flights on daily departures and arrivals from the Asia pacific Region.

#### **Safety;**

India is a very safe country to be in because it is a very popular tourist destination and safe to go around.

The host shall recommend and provide information for site seeing, tourist destinations and packages so that the participants can ensure safety.

There shall be official guides provided from the host side and a separate counter shall be set-up near the registration area for local go around and support.

➤ **Accommodation**

Remote Participation

Live video streaming shall be managed and made available for interested participants and who

are unable to attend. We have provided the same in many of our past events and as per the RFP there shall be no problem for the same. There will be an online platform for remote participants to interact with the panel also.
